LOMAN FRIEDLANDER AWARD ENTRY FORM

BACKGROUND

The Loman Friedlander Award ("Award") was set up in 1990 by the Institute of Patent Attorneys Loman Friedlander Award Trust ("Loman Friedlander Trust") to commemorate a family member's strong interest in the area of Intellectual Property Law.

The purpose of the Award is to reward an original entry paper on any subject falling within the general area of Intellectual Property Law (patents, trade marks, registered designs, or copyright).

TERMS AND SELECTION CRITERIA

The Award is open to an entrant who is (or was at the time of preparing the entry paper) a tertiary student, a New Zealand resident, and of good repute. The Award is made for the best entry paper of between 5,000 and 10,000 words (excluding footnotes) on any subject within the area of Intellectual Property Law. The judges will read the main body of the essay, and not the footnotes. The entry paper must have been prepared by a single author within the past 12 months, and not previously published elsewhere. The entry paper must contain appropriate references, and be submitted electronically, accompanied by this entry form. The entry paper must contain a title, but must not identify the author, as all entry papers will be determined anonymously by the judges.

Loman Friedlander Trust will determine in its absolute discretion whether an entry complies with these Terms and Selection Criteria. In the event that Loman Friedlander Trust determines an entry does not comply with the Terms and Selection Criteria, it may disqualify the entrant and/or revoke the Award. Any decisions or rulings made by Loman Friedlander Trust will be final, subject only to Loman Friedlander Trust's discretion.

The Award is only made if an entry paper of sufficient standard is received, to be determined in the absolute discretion of Loman Friedlander Trust.

ENTRANT'S WARRANTIES

Each entrant warrants and represents that:

- it agrees to accept and abide by the Terms and Selection Criteria;
- it agrees to accept and abide by the decisions or other rulings made by Loman Friedlander Trust;
- that its entry paper was authored by the entrant, within the past 12 months, and while the entrant was enrolled in a course of study at a New Zealand or Australian tertiary institution;
- that its entry paper is original; and
- that the entrant is a New Zealand resident and of good repute.

CLOSING DATE OF ENTRIES

Apply before 30 November each year.

AWARD

Maximum: one Award each year. Value of Award: NZ\$1,000. Award to be announced at the annual NZIPA function in Wellington or Auckland, or an alternate suitable NZIPA function. Award money to be paid into the recipient's bank account within 8 weeks of public announcement of Award.
