Susy Frankel FRSNZ, Professor of Law and Chair in Intellectual Property and International Trade, is a global authority on international intellectual property law. She brings decades of expertise to her teaching, covering pivotal topics such as copyright, patents, trade marks, the protection of mātauranga Māori, and the complexities of global IP regulation. Susy has influenced IP law and policy worldwide, with her work extensively published and cited.

Her distinguished career includes roles in New Zealand as a Chair of the Copyright Tribunal (2011–2020) and as the first independent Hearings Officer of IPONZ. Internationally Susy has been a Global Professor at NYU Law, visiting professor at universities across North America, Europe, and the Middle East. As the former President of ATRIP and a founding director of the New Zealand Centre of International Economic Law (NZCIEL), she is at the forefront of IP scholarship and regulatory reform.
