Entry requirements

An applicant must have completed the requirements for a bachelor's degree from the University of Auckland with a Grade Point Average of 4.0 or higher in at least 60 points above Stage II, or the equivalent from another university as approved by Senate or its representative.

English language: International students must achieve an academic IELTS overall score of 7.0, all bands 6.5 or better or the TOEFL equivalent.

Delivery of courses in the programme

The courses are taught by leading researchers in intellectual property law, and by a range of expert practitioners and IP professionals. The courses are taught in a blended fashion where the primary mode of delivery is face-to-face, but there will also be a concurrent online stream (Zoom) option available.

Topic groups are the subjects which form the curriculum of studies set by the Trans-Tasman IP Attorneys Board to prepare students to practise as patent attorneys and trade mark attorneys. The curriculum for trade mark attorneys consists of 4 topic groups (A1, A2, B, C and D). The curriculum for patent attorneys consists of 9 topic groups. Of particular interest, in 2025 we are offering a 30-point paper, LAWCOMM 738: IP Law in Asia-Pacific. This course is being taught by Dr Wenting Cheng from the University of Queensland.


Students doing a PGCertIP are required to enrol on LAW 700, a zero-point course with no fees.

As well as the above courses, students can also take up to 15 points from another 700 level course offered by the University of Auckland approved by the Programme Director.
